The Association continues to assume a leadership role in supporting members and their families, the hospital staff, and above all the young patients at the hospital. Funding through the endowment also supports the hospital's archives, which collects, preserves and celebrates the history of nursing at SickKids. This includes a collection of over 10,000 nursing-related archive materials including displays for several events including Nursing Week, and 50th Anniversary Luncheons for all classes.

WAYS TO PROVIDE YOUR SUPPORT

GIFT IN WILL Gifts can be made through your will, which will have no immediate cost to you and can often enable you to make a larger gift to SickKids Foundation than you could have during your lifetime. Through your will, you can choose to leave SickKids Foundation a specific sum of money, a percentage of your estate, or a specific piece of property. Gifts made in the will can reduce or even eliminate the final income tax that would otherwise reduce what you are able to leave your heirs.

Leaving a gift for SickKids in your will is a simple but incredibly impactful way of giving. Through a gift in your will, you are helping to provide leading medical care for sick children, educate future generations of health care providers and support discoveries that can lead to recoveries.

Leaving a gift in your will is a fairly simple process. Speak to your lawyer about drafting or revising your will to include the appropriate wording. Sample wording could be: "My estate trustees shall pay the sum of \$ (or transfer assets with an equal value) to The Hospital for Sick Children Foundation, Toronto, ON, for the purpose of supporting The Alumnae Association of the School of Nursing Endowment Fund."

GIFT OF SECURITIES A gift of appreciated publicly traded securities is a tax-smart alternative to a cash donation. You will receive a charitable tax receipt for the fair market value of the donated security, and you will not pay tax on any capital gain, allowing you to give the same amount at a lower cost. Securities can include stocks, mutual funds, segregated funds, bonds, flow-through shares, and employee stock options.

LIFE INSURANCE Using life insurance can be a great option because it requires a minimal investment upfront but can result in a significant gift. When donating a life insurance policy, the best option will depend on whether you seek tax relief during your lifetime or for your estate. Flexible choices allow you to explore donating an existing policy, setting up a new policy as well as naming The Hospital for Sick Children Foundation as an owner and/or beneficiary of the policy.

RRSP & RRIF Retirement funds are one of the best means to grow wealth during your lifetime, but one of the worst ways to transfer wealth to the next generation, as they are among your most heavily taxed assets at the time of death. By naming SickKids Foundation as a beneficiary of registered plans, you will receive a tax receipt for the value of the gift, avoid probate fees by removing these assets from your estate, and significantly reduce the taxes for your estate.
