SICKKIDS FOUNDATION SCRUBS IN THE CITY HEALTH & SAFETY PROTOCOL



At SickKids Foundation, our highest priority is the health and safety of all guests, staff, volunteers, and vendors. As an industry leader, we will continue to work diligently to provide a safe, clean, and healthy environment.

Please note that this document will be periodically updated as new information is made available or as health and safety measures are updated, based on directives from government and public health officials.

The following is an outline of additional steps we have taken to create a safe environment at Scrubs in the City:

CONTRACTING COVID-19

Ahead of event ticket purchase or registration, our event website will require guests to agree to not attend the event if:

- They are experiencing any COVID-19 related symptoms, such as fever, cough, sore throat, shortness of breath or difficulty breathing, or are feeling ill in any other way
- · Have recently travelled outside of Canada (last 14 days) and are currently required to quarantine
- · as per the federal regulations
- · Have had contact with a probable, or confirmed, case of COVID-19; or
- Are awaiting testing or test results for COVID-19.

GOVERNMENT & PUBLIC HEALTH POLICIES

Scrubs will uphold and enforce all policies for gatherings as defined by the provincial government and public health. Current regulations include limitations on gathering sizes, as well as food and beverage service guidelines. We will continue to adhere to all policies in place on the date of the event.

PROOF OF VACCINATION

Health and safety during the COVID-19 pandemic has been our top priority. As a member of the broader SickKids Hospital community, it is imperative that we do our part to protect all those carrying out activities on SickKids-related premises.

SickKids Foundation requires all Scrubs in the City guests, staff, vendors, and volunteers attending the event to be fully vaccinated against COVID-19 (a mix of at least 2 accepted vaccines or at least 1 dose of the Janssen/Johnson & Johnson), with the exception of those with a validly documented medical or human rights exemption which must be provided to SickKids Foundation in advance. Proof of vaccination is required even if that exceeds the minimum government and public health guidelines. Proof of vaccination along with a government issued ID will be required upon check-in. By purchasing event tickets, you agree to comply with this policy.

FACE COVERINGS

If at the time of the event, face masks are not required at events as per government and public health rules and regulations, then they will not be required at the event. We must all remember that the COVID-19 pandemic is not over and show respect and support for those who continue to practice masking and other safety measures moving forward.

CLEANING & SANITIZATION

All food & beverage services will fully comply with City of Toronto Public Health and Ministry of Health agencies guidance and direction on safe service practices and physical distancing measures. Hand sanitizer will be provided at entrance/exit points. Washrooms will be cleaned and disinfected every hour with instructions to cleaning staff to disinfect push plates, sink faucets, counters, toilet handles, lids of sanitary napkin bins, soap, and paper towel dispenser handles.

REFUND POLICY

All purchased event tickets are non-refundable.

In the event that SickKids Foundation cancels Scrubs in the City Nashville due to COVID-19 restrictions or unforeseeable circumstances, we will provide guests with the option to either defer their purchased tickets to the following year, convert their tickets to a donation to SickKids Foundation or receive a refund.
